The payment of the bills and the investment report were submitted for the boards review. Mrs. Southern announced that Melissa Karnei and Lara Parker were both named employee of the month. Currently, NISD has 128 students. We have had a steady cycle of students leaving and others enrolling. Based on the latest benchmark, the data is looking good and moving in the right direction. We will continue to work toward student growth. Dr. Gajewskey reported that all efforts are focused on the upcoming STAAR. We have implemented Saturday School and Tip Top Tuesday to target student outcomes. The next community event is Spring Fling, Saturday, April 1, 2023. Spring Fling will be held at NISD and is open to the community. PTO has done a fantastic job preparing for this. The fire alarm system has not been repaired and is problematic. Dr. Gajewskey reached out to other companies and has obtained bids. He will file an insurance claim for the replacement of the system, in which all components will be new, including the wiring. He has been in contact with TASB and this will only cost NISD the deductible, which has likely already been met in repairs. NISD is currently waiting on the final payment from TEA, as two have already been processed. The information is at the Comptroller's office. Once the final payment is sent, NISD will pay STEC the amount owed. KLC completed the remaining safety components regarding door camera access, front office push button entry and card readers. Finally, Dr. Gajewskey informed the board that other surrounding districts are offering incentives for retention and hiring in order to attract candidates. Dr. Gajewskey will gather data from the surrounding districts and present this later in the summer so that NISD can review teacher compensation packages.

Each year, NISD uses the P&G materials for the 4th and 5th grade Human Growth and Development Lessons. The Board asked clarifying questions regarding the details of the instruction and parental rights. Neal Stevenson made the motion to approve the Proctor and Gamble Human Growth and Development Resources. Missy Yearwood made the second. The vote was unanimous.
